What is this product?

Type

The Fund is a unit-linked insurance fund operated by Invesco Pensions Limited ("IPL"). Investments can be made via a Trustee Investment Plan, a unit-linked life insurance policy issued by IPL to eligible UK registered pension schemes.

Objectives

- The objective of the Fund is to provide income while maintaining the value of the investment.
- Any income generated will be reinvested into the value of the Fund.
- The Fund invests entirely in the Invesco Money Fund (UK), a standard variable net asset value money market fund managed by Invesco (the "Underlying Fund").
- The Underlying Fund invests primarily in a portfolio of investment grade or of similar quality, sterling denominated money market instruments.
- The Underlying Fund may use derivatives (contracts whose value is linked to the value of an underlying investment) to hedge interest rate or exchange rate risk.
- The Underlying Fund is actively managed within its objectives and is not constrained by a benchmark.
- The return of the Fund corresponds directly to the return of the Underlying Fund, which in turn will depend on the value of the assets it invests in and the income they generate.

Intended Retail Investor

The Fund is intended for trustees of UK Registered Pension Schemes aiming for income and capital preservation, who may not have specific financial expertise but are able to make an informed investment decision based on this document and the Key Features Document, have a risk appetite consistent with the risk indicator displayed below and understand that there is no capital guarantee or protection (100% of capital is at risk).

Term

The Fund does not have a maturity date and may only be closed unilaterally in accordance with the terms of the contract between you and Invesco Pensions Limited.

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 1 out of 7, which is the lowest risk class. This rates the potential losses from future performance at a very low risk level, and poor market conditions are very unlikely to impact the product's performance.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see the section "what happens if we are unable to pay you"). The indicator shown does not consider this protection.

Fixed income securities to which the product is exposed are open to credit risk which may result in issuers not always making interest and or other payments nor is the solvency of the issuers guaranteed.

Investing in the Underlying Fund is not the same as making a deposit in a bank account. Variable NAV means the value of the shares in the fund (the "NAV per share") can go up and down depending on how the underlying assets of the fund perform. The fund does not rely on any external support for guaranteeing its liquidity or stabilising the NAV per share. Your investment is not guaranteed and you may not get back the full amount invested. Over time, inflation may erode the value of investments.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. The figures assume you invest £10,000. The figures are estimates and may change in the future.
